

1. Intergroup should be called Area Service Committee and Delegates should be called Group Service Representatives.
2. The Secretary of ASC should send a list of meetings to WSC.
3. GSR should have 6 months of Sobriety (Drug & Alcohol)
4. Group business meetings should be called Steering Committee Meetings.
5. The steering committee is made up of, Group Service Rep, the Alternate, Secretary and Treasurer, and members of the group.
6. The secretary of the group responsibilities are the same as the old chairperson and should appoint Leader for the meeting. They should hold the position for 1 year.
7. There should be a sincere effort to try these changes on the group level for 1 year.
8. The treasurer has the responsibility of keeping financial records, Group bank account, pays the rent, buys coffee, buys supplies.
9. GSR serves for 1 year and the Alt for 1 year. The Alt has ^a ~~no~~ voice *but no* vote and automatically becomes GSR after serving 1 year. Elections for GSR and Alt on group level are held in Nov. and elections for ASC are held in January.
10. If a GSR or Alt do not show up for 3 months the group goes off the meeting for 3 months.
11. (Intergroup) now known as ASC should be split into 3 separate ASC. Consisting of the Phila And Bucks County meetings, the Montgomery County and Mt Penn meetings, and the Scranton area meetings. *SEE SECOND PAGE FOR 11A, 11B, 11C*
12. The bylaws of ASC should be called Guidelines.
13. Each ASC should draw up its own guidelines and given to The Regional Service Committee.
14. The RSC consists of all the ASC.
15. The RSC should set up a subcommittee for Institution meetings.
16. The RSC is there to meet the needs of ASC.
17. The RSC should have the responsibility of setting a committee in the region for Round Ups, New Year Eve Dances, etc.
18. The RSC should provide meetings lists for the ASC, Groups, and Members.
19. The RSC meets quarterly. It rotates to a different ASC each and that ASC arranges for the meeting place.
20. The RSC would have a literature chairperson and the ASC would have one to.
21. The ASC donates quarterly to the RSC and the RSC donates yearly to WSC.

22. The RSC consists of all GRS, Alt, and officers from each ASC.
23. The RSC elects a Chairperson, Vice Chairperson, Secretary, and Treasurer from those members of RSC.
24. The officers of RSC have no voice or vote in RSC.
25. The ASC should provide the RSC minutes of their meetings.
26. The Tree Committee feels that its purpose ~~and~~ promote greater unity in N.A. and this must start with greater awareness of responsibility starting with the member and working up.
27. RSC needs guidelines like the ASC.
28. Each RSC and ASC should have their mailing address.
29. ASC and RSC should have a definitive statement and should be written by the Literature Committee.
30. There should be a more structure format for RSC than ASC.
31. Guidelines should define the functions and responsibilities of its members officers and subcommittees (guidelines should be suggestions & should have some flexibility).
32. GENERAL SERVICE DELEGATE- One is elected from RSC & is the link between his region & N.A. as a whole -they attend the annual World Service Conference
33. Each ASC nominates one person -the GSR takes the nomination to their group and that person is voted upon-the nominee from each ASC are voted upon and the person elected is the GSD.
34. The GSD serves for 2 years 1st as Alt. and 2nd year as voting delegate.
35. " " should be Sober for 2 years, have a commitment to service, service experience, willingness to give time & resources necessary, and a good working knowledge of the 12 Steps and Traditions of our Fellowship.
36. The GSD should be familiar with WSO, World Service Board, and World Service Conference.
37. The ASC is set up to advise, give support, direct, educate, but not to discipline
38. RSC should meet the 3rd Sunday of each ~~quarter~~ quarter starting in January 1977.
39. ASC as is now will meet for the last time in August-1976-after that each ASC will meet each month on their own.
40. Meeting List- The GSR from each group has until August 1976 to bring back address and corrections on meeting for a new meeting list. After August no changes will be made until January 1977. Meeting lists after that will be made up and supplied for the groups in the region by RSC.
41. The Secretary of RSC should write WSO and obtain the N.A. tax number for the 3 ASC and the individual groups to use for its various functions.

FINANCIAL SUPPLEMENT REPORT-PRESENTED AUGUST 1, 1976
