Note: Although Miami and W. Palm Beach were only forty miles apart neither was aware of the other's existence. Neither had knowledge or communication with the other until 1979, although both were communicating with the WSO regularly. 1977-79- N.A.'s growth was insignificant, if any during this period of time. The meetings remained small and obscure to their communities. Members used N.A. as a special purpose group to A.A. (Although, Miami had a "club room" which was called the "Back Room", 79th & Biscayne, the meetings remained small and peaked at four to a low of two.) The club closed in May of 1980 due to inner strife. West Palm Beach started a second meeting closed to addicts only, they remained so autonomous, they did not communicate with Miami or Fort Lauderdale. Fort Lauderdale had only their one meeting and remained small and regular attendance was a handful. This group also functioned as an offspring of "Y.P. in A.A." There was no possibility for recovery in N.A. All these meetings were in the southeastern part of Florida.

Bob B. and got a lot of feedback and gave input because we have strong interest in Hospital & Institution work. Last year we hosted WCNA-11. We had our doubts as to whether it would ever materialize but it did, with about 200 out of state addicts in attendance. There were 600 all together. Also had a letter from State HRS, Health Rehab Service, which are bringing NA meetings into their instituions, asking members of those organizations to attend open NA meetings and think about bringing NA into their structure. Also we have a group in St. Croix, been sent literature and I believe they are now registered with the World Service Office and we have been trying to help them as we are the nearest region.
