The first N.A. meetings in eugene Oregon, in 1978, were small, hidden meetings which didn't last very long the members kept getting loaded. Another hidden meeting started in Junction City in mid 1979, with four members. It lasted until Jan. 1979.

As the Junction City group was desolving, two addicts in Eugene needed a meeting desperately. A member who had been the Secretary of one of the former Eugene groups, and was getting ready to pawn her jewelry, so she could score. A member had just moved to Eugene from Germany, had a world Service Directory which listed her phone number and called her and they shared their need for a meeting She arranged to hold a Saturday night meeting in the apartment where her husband's A.A. sponsor lived. She invited several of the members of the Eugene and Junction City groups and Eugene began having open N.A. meetings. The members began 12 stepping and recruting from A.A., and soon the apartment was filled with clean addicts. Within three months two more groups sprand up. Another member started a monday night meeting, three members began working with inmates in the Lane County Jail, and by July 1979, they had started a meeting in the jail.

Eugene N.A. had it's share of setbacks in the first year. The members took turns being suicidal or relapsing, and at one point mearly hald the membership sot loaded. Officers got loaded on the group money, traditions were biolated, and meeting places were always changing. God always seemed to keep a couple of members strong enough to keep the ball rolling, however, and the meetings grew. A member visited a few times and prompted us to organize an area. Eugene sent representatives to two of the Siskyion Area Service meetings, but the distance proved too great for regular attendance, so we formed our own Area Service Committee. A member held a potluck ASC meeting at his house, and we began to learn about

fellowship. The ASC remained small until the summer of 1982, when members moved to Eugene from the Coast, and two members with 25-30 members attending, and formed several committees to handle service work. Eugene began activity participating in the Northwest Regional service structure, and membership grew rapidly.
